





- The Kuwaiti cabinet said on Thursday that it will start implementing the fourth stage of the gradual go-to-normality plan on August 18 and some activities that were set to open during the fifth stage including gyms, sport clubs, beauty salons and tailors will now be open as a part of the fourth stage.
- Kuwait has cut the official selling prices (OSPs) for crude grades sold to Asian refiners in September to 70 cents per barrel above the average of DME Oman and Platts Dubai quotes, down 35 cents from the previous month
- Kuwait Oil Company said on Wednesday it has contained and isolated the source of an oil leak that occurred on Tuesday night, located near Kilo 18 of the Seventh Ring Road.
