





#### In News

- Total Sukuk issuances worldwide set a new record during 2020, reaching a total of USD 172.1billion, compared to USD 169.1billion issued in 2019, according to Refinitiv.
- In Kuwait, the legislative committee will discuss the imposition of fees on remittance outside the country, regardless of the currency individuals or companies who do the transfers for a sum of 1% of the total sums transferred.
- Kuwait's Agility Public Warehousing Company is looking increase its available credit lines to around USD 1.4billion. It has so far refinanced and increased its credit facility line from USD 725million to USD 800million with existing and new local, regional and international banks.
- The unemployment rate among Saudis dropped to 14.9% in the third quarter of 2020 from 15.4 percent in the second quarter while it rose compared to 11.8% in the first quarter, the Saudi General Authority for Statistics announced. Dividend payments from Aramco and PIF helped Saudi Arabia ease its fiscal balance. The 2020 preliminary fiscal deficit stood at SAR 298billion or 12% of GDP estimates for the year.
- MENA's installed solar capacity to reach 35 gigawatts by 2023, according to the UAE-based Middle East Solar Industry Association (MESIA).
