





- Kuwait raised the official selling prices (OSPs) for two crude grades it sells to Asia in January from the previous month. The producer has set January Kuwait Export Crude (KEC) price at \$2.80 a barrel above the average of Oman/Dubai quotes, up 65 cents from the previous month.
- Fitch rating's 2022 sector outlook for Middle East banks is neutral, reflecting a modest expected economic recovery.
- Zain said it had received a non-binding \$1.3 billion offer for the telecom group's Sudanese business from a subsidiary of Sudan's DAL Group.
- GFH and Wafra International create strategic partnership to acquire portfolio of FedEx US logistics assets.
- Kuwait Financial Centre signs short term Murabaha Facility with local bank for 8 million Kuwaiti Dinars.
- Jazeera Airways launches first ever route between Kazakhstan and Kuwait.
