







#### In News

- The total value of Kuwait export to the world reached 312.1 million dinars (Approximately \$ 1 billion) in first seven months of 2022. The highest percentage of Kuwait export went to GCC countries with a value of KD 183.7 million, followed by group of Arab countries with KD 95.9 million.
- Energy, fuel subsidy consume more than half of Kuwait Government budget's total subsidy nearly KD 2.03 billion out of KD 4 billion.
- The State Audit Bureau highlighted in a report that a number of steps must be taken in order to address the general budget's ongoing fiscal deficit in recent years, the most crucial of which is to diversify public revenue sources and lessen its reliance on oil earnings while adhering to a rigorous financial plan.
- The new "buy now, pay later" product will be tested by the central bank of Kuwait (CBK) in its regulator sandbox environment before being on sale in the country. The CBK has praised the effort as one of the bank's unique business strategies.

#### **Financial News:**

- Warba Bank reported a net profit of KD 3.8 million, compared to KD 3.1 million for the same period in 2021, improving by 22.6% year-on-year.
- Ahli United Bank reported net profit for its shareholders of KD 10.1 million up to the end of Q3 of 2022; an increase
  of 12.2% compared to the same period last year.
- Ooredoo Kuwait reported a net profit of KD 12 million, compared to KD 6.5 million for the same period in 2021, improving by 84.6% year-on-year.
- Mabanee reported net profit of KD 15.5 million up to the end of Q3 of 2022; an increase of 9.2% compared to the same period last year.
- Commercial Facilities Company reported a net profit of KD 1.3 million, compared to KD 4.8 million for the same period in 2021.
