





#### In News

- Kuwait is working on implementing sustainable energy projects totaling \$6.3 billion, however it only has 0.5% of the installed clean energy capacity.
- The Central bank of Kuwait (CBK) raised its discount rate by 50 basis points to 4% from 3.50% to suppress inflation and maintain currency stability.
- The real GDP and inflation rates in Kuwait are expected to increase by 2.8% and 3.2%, respectively, in 2023, according to the UN prediction.
- Oil revenues for FY 2022–2023 are forecast to surpass KD 25 billion for the first time in years, after revenues in the previous three quarters were roughly KD 20 billion, as oil prices are likely to remain constant in 2023.

#### **Financial News**

- Kuwait Airways reported a revenue rise of 115% in 2022 compared to 2021 and 10% compared to Pre-Pandemic level 2019. It also reported a loss of KD 55 million.
- Aayan Leasing and Investment reported a net profit of KD 2.3 million in Q4 2022 compared to KD 479,453 a
  vear ago. It also announced a cash dividend of 7.5fils per share.
